1. Advertisements are released in a newspaper for admission to Diploma program well before the declaration of 10<sup>th</sup> standard results.
2. Applications are issued to the candidate on payment of the prescribed fee. The applications are issued in the SRI KRISHNA POLYTECHNIC COLLEGE OFFICE and Outstation candidates can apply through Online. The online Application form will be available in [www.skptc.srikrishna.ac.in](http://www.skptc.srikrishna.ac.in) official website. As per Government norms application is issued at free of cost to SC/ST candidates on submission of community certificate in the College Office.
3. Last date for submission of application is fixed as seven days from the publication of SSLC results.
4. The applications are scrutinized and a rank list is prepared based on merit (total marks obtained).
5. DOTE nominate an expert to oversee the admission process.
6. The counseling cum admission dates are finalized in consultation with DOTE nominee.
7. Counseling cum call letters are send to the shortlist candidates informing the Date and Session of counseling and fee to be paid at the time of admission.
8. Counseling cum admission is done following the merit and communal reservation. One parent is permitted to remain with the Candidate during for counseling.
9. Once a candidate is allotted a branch of his/her choice then he/she has to pay the fee immediately and get admitted to the programme.
10. For Aided Courses Government Quota: 90% MQ: 10% for Self Financing Courses Government Quota: 50% MQ: 50%.

11. Entrance test: Not applicable. Criteria and weightage for admission Candidates will be called for single window counseling as per the rank order at SRI KRISHNA POLYTECHNIC COLLEGE OFFICE and seats will be allotted following merit and communal reservation. The State Government/ UT/ Directorate of Technical Education/ Directorate of Medical Education shall ensure that 10% of reservation for Economically Weaker Section (EWS) as per the reservation policy for admission, operational from the Academic year 2019-20 is implemented without affecting the reservation percentages of SC/ ST/ OBC (NCL)/ General. 2. The Institution offering courses earlier in the Regular Shift, First Shift, Second Shift/Part Time are now amalgamated as total intake and shall have to fulfil all facilities such as Infrastructure, Faculty and other requirements as per the norms specified in the Approval Process Handbook 2022-23 for the Total Approved Intake. Further, the Institutions Deemed to be Universities/ Institutions having Accreditation/ Autonomy status shall have to maintain the Faculty: Student ratio as specified in the Approval Process Handbook. All such Institutions/ Universities shall have to create the necessary Faculty, Infrastructure and other facilities WITHIN 2 YEARS to fulfil the norms based on the Affidavit submitted to AICTE beginning with the Academic Year 2022-23
3. Strict compliance of Anti-Ragging Regulation, Establishment of Committee for SC/ ST, Establishment of Internal Complaint Committee (ICC), Establishment of Online Grievance Redressal Mechanism, Barrier Free Built Environment for disabled and elderly persons, Fire and Safety Certificate should be maintained as Approval Process Handbook and provisions made in AICTE Regulation notified from time to time.
4. In case of any differences in content in this Computer generated Extension of Approval Letter, the content/information as approved by the Executive Council / General Council as available on the record of AICTE shall be final and binding.

**Pharmacy Institute:** In compliance with the order dated 05.03.2020 passed by the Hon'ble Supreme Court of India in Transferred Petitions (CIVIL) No 87-101 of 2014, for the existing institutions offering courses in Pharmacy Programme, approval of Pharmacy Council of India (PCI) is mandatory and AICTE approval is NOT required.
